### 1. Introduction

Oscillon Chronos ("we," "our," or "us") values your privacy and is committed to protecting the personal information you provide through this Mental Health Initiative Forum ("Forum") at [<https://oscillonchronos.com/forum/mental-health-initiative/>] This Privacy Policy outlines the types of information we collect, how it is used, stored, and the security measures in place.

### 2. Information Collection and Purpose

The Forum collects specific personal and non-personal information solely for the purpose of conducting a survey to understand how Oscillon Chronos can better support mental health initiatives. By submitting this Forum, you agree to the collection and processing of this data.

### 3. Data Storage and Security

The information collected from this Forum is securely transmitted to our cloud storage using a REST API hosted on AWS. Once received, your data is stored in AWS DynamoDB (ap-south-1) and AWS Glacier S3 in Mumbai, India, managed under strict security protocols with encryption keys maintained by AWS.

Data Protection Measures Include:

**Encryption:** All data is encrypted at rest and in transit.

**Access Control:** Access to stored data is restricted to authorized personnel within Oscillon Chronos, who adhere to confidentiality and privacy policies.

### 4. Data Usage

The information collected is used only for the purposes of improving Oscillon Chronos's mental health initiatives. Oscillon Chronos will not sell, lease, or disclose your information to third parties except as required by law or where you provide explicit consent.

### 5. Data Retention

Data collected via the Forum will be retained only for as long as necessary to fulfill the survey's purpose or as required by applicable law. While Oscillon Chronos does not currently have a formal data retention policy, any personal information will be stored securely and deleted once it is no longer needed for its intended purpose.

## 6. Your Rights

You have the right to:

**Access:** Request a copy of the information we hold about you.

**Correction:** Request correction of any incomplete or inaccurate information.

**Deletion:** Request deletion of your data, subject to legal requirements.

**Data Portability:** Request transfer of your data to another service provider, where feasible.

This Forum is open for users aged 16 and older. Oscillon Chronos does not knowingly collect information from individuals under 16. If you are under 16, please do not submit any information through this Forum.

Oscillon Chronos reserves the right to pursue all available legal remedies, including but not limited to initiating lawsuits against individuals or entities involved in violations. Such legal actions will be initiated in the courts located in Jaipur, Rajasthan, India.
